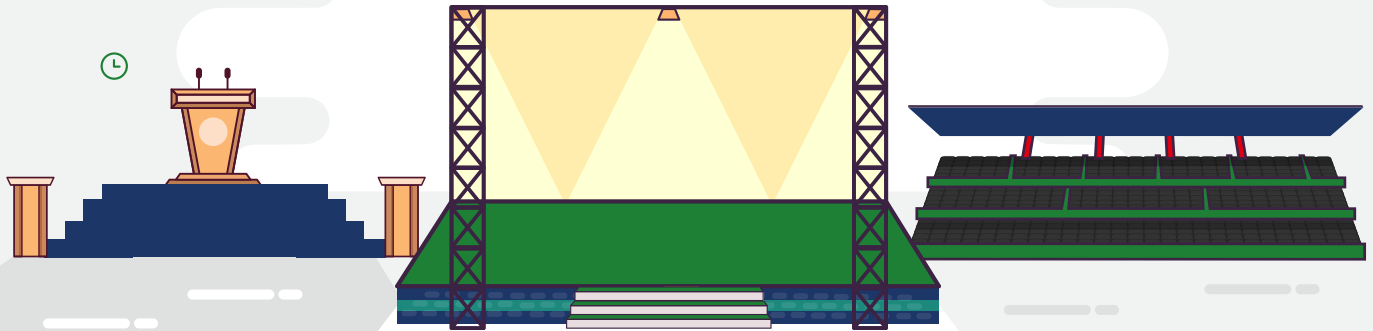

About Us

Oman Re is the first reinsurance company to be established in Oman with the purpose of writing Facultative and Treaty business from local and international markets. Rated B+ (Good) by A.M. Best, Oman Re's current territorial scope includes all Afro-Asian countries and it writes marine and non-marine lines of business.

Oman Re was incorporated in July 2009 in the Sultanate of Oman with a paid-up capital of OMR 5,000,000. Capital was gradually increased to OMR 30,000,000 (Thirty million Omani Riyals), equivalent to circa USD 78,000,000.

Trust International Insurance and Reinsurance Company B.S.C. (c) Trust Re is the major shareholder of Oman Re.

The company's values of Integrity, Dynamic Culture and Transparency ensure that all its operations are carried out to the highest standards.

Oman Re is rated B+ (Good) by A.M. Best.

Events Cancellation

- Capacity Limit: We are targeting small and medium size events with sum insured up to \$900,000 (OMR 350,000) per declaration. Larger Events are also welcomed.
- Minimum Annual Net Premium: \$750 (OMR 300) for our share.
- Geographical Scope: GCC and Lebanon only.

Guide to Appetite and Exclusions by Class

Our appetite for Events Cancellation is to target small and medium risks. The following Classes of Coverage can be offered: Cancellation, Non-Appearance, Adverse Weather, Contingent Terrorism.
